**Re: Expiring Temporary Emergency Licence M570-E02 for Rockwood Terrace Home for the Aged (Home #M570)**

---

I am writing with regards to the Temporary Emergency Licence # M570-E02 that was issued to Rockwood Terrace Home for the Aged effective March 25, 2020 to March 24, 2021. The Temporary Emergency Licence was issued to support Ontario's response to the COVID-19 pandemic.

Under the *Long-Term Care Homes Act, 2007* a Temporary Emergency Licence can only be issued with a maximum term of one year. The ministry's review of occupancy and vacancy rates at Rockwood Terrace Home for the Aged demonstrates new admissions can be accommodated within the home's regular licensed capacity and that no residents will be displaced once Licence # M570-E02 expires. As such, the ministry is confirming no new Temporary Emergency Licence will be issued upon the expiry of Licence # M570-E02.
