County of Grey GIS Intranet Site - Terms of Use

The following outlines the terms and conditions for using the Grey County GIS Intranet Site. Each staff member must sign the Terms of Use Agreement and must be authorized by the Department Head.

Definitions

“Data” means digital databases or data layers distributed by the County of Grey

“County” means the Corporation of the County of Grey

“Recipient or User” means the staff member that receives and/or uses the data provided through the County GIS Intranet Site

“Site” means the County GIS Intranet Site which is a password restricted site

Terms and Conditions

The following terms and conditions apply to the release of the data contained on the County GIS Intranet Site:

The assessment data contained in this site shall be used exclusively for internal planning-related purposes in Grey County;

The User shall under no circumstances provide the assessment data to anyone at any charge, including free of charge. Under Section 53 of the Assessment Act, any User who willfully discloses or permits to be disclosed any such information to any other person not likewise entitled to accessing this information is subject to a fine of not more than \$2000 and/or to imprisonment from a term of not more than six months;

The User is responsible for protecting their assigned username and password. The User shall under no circumstances share their username and password with anyone. The use of the site will be tracked internally and any unusual activity could result in the removal of access privileges;

The data available on the Site is provided as is, with all faults, and without warranty of any kind, either expressed or implied, including, but not limited to, the implied warranties of merchantability and fitness for a particular purpose;

The User understands and acknowledges that the products and information contained therein are subject to constant change and that its accuracy cannot be guaranteed. The County makes no warranties or guarantees, either expressed or implied, as to the completeness, accuracy, or correctness of such products, nor accepts any liability arising from any incorrect, incomplete or misleading information contained therein;

The County shall not be subject to liability for any lost profits or consequential damages, or claims against the User by third parties. The entire risk as to the quality, performance and usefulness of the data rests with the User;

Maps produced using the Site shall under no circumstances constitute a legal survey document and should not be relied on as being a precise indicator of routes, locations of features, nor as a guide to navigation;

The data available on the Site are from a variety of external sources, and are subject to change at anytime without notice;

The data and maps provided by the Site are not to be used as a substitute for specific advice from a qualified professional. Before acting upon information in this site, it is strongly recommended that you independently verify the data, and where necessary, obtain professional advice;
